N.Y. Dept. of Transportation Commissioner Hennessy has modified the heavy truck ban to allow trucks routed to Orangetown to use routes 9W and 340. The Tri-State Committee, which is headed by the N.J. Dept. of Transportation Commissioner, effectively nullified the ban; which was implemented, and later upheld in Federal Court, for reasons of safety. Nothing has occurred to change the court decision.

In itself, the modification won't greatly increase the number of heavy trucks on the roads. Enforcement, however, is difficult partly because the modification includes the portion of Nyack which is in Orangetown. opens up the 9W corridor to the Tappan Zee Bridge and the N.Y. Thruway. Even though a marking system is being considered to identify legal trucks, the Orangetown police are unable to patrol 9W and 340 continually. Inevitably, illegal long-haul trucks will pass through. Chief Crable and Sgt. Johnson of the Orangetown police have said "It's going to be a tough enforcement problem".

This weakening of the ban was unnecessary. A letter from Supervisor Colello to the Tri-State Regional Planning Commission on Aug. 28, said that Orangetown industry was not being adversely affected by the ban.

It is questionable, too, what the modification does for New Jersey. A truck count recently taken by the N.J. police at Closter Dock Rd. and Piermont Rd. in Closter showed that most of the trucks had an origin or destination in Bergen County.

Sen. Winikow assures us that Commissioner Hennessy will not allow anymore inroads into the ban. She said (and asked to be quoted), "This is the most N.J. is going to get away with". When asked about the Tri-State's suggestion for a route to connect 9W and 303 in N.Y. she said the responsibility for that is with New Jersey, not New York.

Mayor Bryan of Piermont is asking for a 30-day extension to consider alternatives and to allow time to work out the truck tagging system. We also plan to ask the DOT for some changes; a speed limit reduction on 9W south of the Sparkill viaduct and on 340 north of Oak Tree Rd., with no passing zones.

We continue to have heavy traffic from Rockleigh Industrial Park and the other N.J. industries and the traffic is spilling onto Closter Rd. Rockleigh continues to expand, along with Northvale and Norwood, affecting our safety, peace, and property values.

Clearly, the ultimate solution is a 9W-340 connecting route in New Jersey. Page 17 of the Tri-State's 19 page report <u>finally</u> mention's that maybe something should be done in New Jersey.

To join the effort to do something about the traffic problems in our area, please call me at 359-3207.

Meanwhile, remember that Oak Tree Rd. has a 5-ton limit. The truck traffic has already increased and will worsen when the ban is modified. In order to avoid the terrible situation of 2 years ago, before the ban, please call the police to report any illegal trucks.
